

**PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS

DANGER

Causes severe eye and skin damage. Repeated exposure may cause allergic skin reactions. Do not get into eyes, on skin or clothing. Wear goggles or face shield with rubber gloves. Harmful if swallowed. Wash thoroughly with soap and water after handling and before eating or using tobacco. Remove and wash contaminated clothing before reuse.

FIRST AID

IF IN EYES:	<ul style="list-style-type: none"> Immediately flush with plenty of water. After initial flushing, remove contact lenses and continue flushing for 15 minutes. Have eye examined and treated by medical personnel.
IF ON SKIN:	<ul style="list-style-type: none"> Immediately wash off material with soap and plenty of water. If irritation persists, obtain medical attention. Wash contaminated clothing and decontaminate footwear before reuse.
IF SWALLOWED:	<ul style="list-style-type: none"> Do not induce vomiting. If conscious, promptly have victim drink a large quantity of water. Avoid alcohol. Never give anything by mouth to an unconscious person. Refer victim to medical personnel.

NOTE TO PHYSICIAN:

Probable mucosal damage may contraindicate the use of gastric lavage following ingestion. Measures against circulatory shock, respiratory depression and convulsion may be needed.

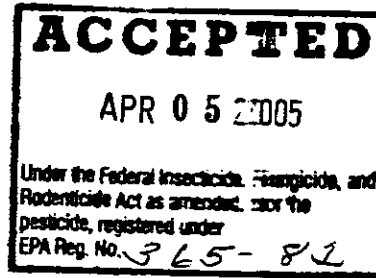
