

REVISED LABELING

"ARNOLD" CHLORDANESPRAY CARTRIDGE  
Spraying Instructions

This cartridge contains\*Technical Chlordane in a water dispersible form combined with spreader and wetting agent. It is intended primarily for use in combating ants, earwigs, cutworms and the grubs of Japanese beetle and June bug. \*Equivalent to 24% Octachloro-4, 7-Methanotetrahydroindane, and 16% of related compounds.

**HAZARDOUS PROPERTIES:** Harmful if swallowed. Skin contact may cause toxic symptoms. Toxic to fish and wildlife. **KEEP OUT OF REACH OF CHILDREN.**

**PRECAUTIONS:** Do not use this product contrary to label directions. This product is toxic to fish, birds and other wildlife. Birds feeding on treated areas may be killed. Keep out of lakes, streams, or ponds. Do not apply where runoff is likely to occur. Do not apply when weather conditions favor drift from areas treated. Do not contaminate water by cleaning of equipment, or disposal of wastes. Apply this product only as specified on this label.

**FIRST AID:** For skin contact, wash with soap and water. If in eyes, flush with plenty of water. If swallowed, induce vomiting. Get prompt medical attention.

**NOTE TO PHYSICIAN:** The administration of barbiturates is beneficial. Avoid use of adrenaline and morphine. Oxygen may be indicated.

**VEGETABLES:** For control of cutworms. Apply to stems and soil around seedlings and small transplants of tomato, pepper, beans, peas, squash and sweet corn. Most effective on warm evenings. Repeat after cultivation, heavy rain and in 7-10 days, if necessary.

**CAUTION:** Do not apply to vegetable crops after edible parts begin to form.

**TURF:** For control of grubs of Japanese beetle and June bug. For best results this cartridge should be applied to not more than 150 square feet of turf for more effective control. Wash with hose promptly to remove residue from grass leaves. One application annually preferable in spring or fall should be sufficient but additional treatments may be required during summer to combat chinch bug. For control of ants apply to ant nests, hollow trees, foundations of buildings. Do not use in buildings. For control of earwigs, apply around foundation of buildings and under shrubbery where earwigs are present.

**CAUTION:** Do not apply to new lawns. If reseeding, wait one month after treating soil. Do not allow livestock to graze in treated areas.

**NON-WARRANTY:** Seller's guarantee shall be limited to the terms of the label and subject thereto the buyer assumes all risk to persons or property arising out of use or handling and accepts the product on these conditions.
