APPLICATIONS WITHIN FOOD AREAS OF FOOD HANDLING ESTABLISHMENTS

FOOD HANDLING ESTABLISHMENTS

Places other than private residences in which exposed food is held, processed, prepared or served.

FOOD AREAS - APPLICATION LIMITED TO CRACK AND CREVICE TREATMENT ONLY

Includes areas for receiving, storage, packing (canning, bottling, wrapping, boxing) preparing, edible waste storage and enclosed processing systems (mills, dairies, edible oils, syrups). Serving areas (when food is exposed and facility is in operation also would be considered a food area).

Apply in small amounts directly into cracks and crevices using bulbous duster or other suitable equipment capable of applying insecticide directly into cracks and crevices in points between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls, equipment legs and bases, where cockroaches and ants hide.

Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food or food processing surfaces.

APPLICATION IN NON-FOOD AREAS

NON-FOOD AREAS - Includes garbage rooms, lavatories, floor drains (to sewers), entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, men closets and storage (after canning or bottling).

COCKROACH CONTROL - For control of resistant and non-resistant cockroaches (waterbugs) inside and under dwellings and other buildings, apply to baseboard areas, around water pipes, surfaces behind and beneath sinks, lockers, tables, pallets and similar areas where insects hide or through which they may enter. Treatments should be repeated as infestation warrants.

When used in dwellings, the dust should be placed only in areas inaccessible to children and pets. Any powder visible after application is completed should be carefully brushed into cracks and crevices or else removed.

ANT CONTROL - Thoroughly dust ant trails and areas around door sills and window frames where the ants may enter. Treat the openings around water pipes, heat ducts, electrical outlets and baseboards where ants may come into rooms from wall spaces and partitions. Repeat applications as necessary.

CAUTION

Dust only in areas inaccessible to children and pets. May be absorbed through skin. Harmful if swallowed. Avoid breathing of dust. Avoid contact with skin, eyes and clothing. Avoid contamination of food and foodstuffs. Wash thoroughly after handling. **KEEP OUT OF REACH OF CHILDREN.**

Do not reuse empty container. Destroy it by burying with waste or burning. Stay away from smoke or flames.
