Directions for Use

Roaches, Ants, Waterbugs, Silverfish, Spiders, and Crickets:

Spray heavily in all cracks around baseboards, and other places where these insects hide. Also spray until wet, surfaces behind and beneath cabinets, refrigerators and sinks. Use on other localized areas infested with these pests. Repeat treatment as required.

Carpet Beetles:

Make localized application to areas of the floor and baseboards. Spray directly into cracks and under carpets where insects may be found. Repeat as necessary.

Brown Dog Ticks:

Thoroughly spray infested areas around baseboards, window and door frames, wall cracks, sleeping quarters of household pets and localized areas of floors and floor coverings. Applications should be repeated as infestations warrant and as reinfestations occur. Fresh bedding should be placed in animal quarters following treatment. Do Not Treat Animals With This Formulation.

Flies, Mosquitoes, Wasps and Flying Moths Outdoors:

For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames, or wherever these insects may enter the room. Also treat surfaces around light fixtures on porches, in garages, and other places where these insects alight or congregate.

Fleas and Chiggers:

For treatment of localized infestation of these insects in outdoor areas where there is no vegetation, spray thoroughly. Repeat applications as reinfestations occur.

IV. Caution:

Harmful if swallowed. Keep out of reach of children. Avoid contamination of feed and foodstuffs. Avoid repeated or prolonged inhalation and skin contact; wash thoroughly after using. Do not use on household pets or humans.

Combustible Mixture:

Do not use or store near heat or open flame. Do not smoke while using.

Petroleum Distillates	99.18%
