GENERAL INFORMATION**

Residex Resicide Fogging Concentrate 3610 is designed for use undiluted in mechanical sprayers, which give particle sizes of aerosol size, such as the Micro Gen machines. It can be diluted with refined kerosenes which meet Food Additive Regulation 121.1182 and can be applied in fogging equipment that gives larger than aerosol particle size, such as the Microsol or Challenger machines. It can also be diluted with oil specified above and applied as a contact spray to kill crawling insects shown later on this label.

Space Spray - Undiluted in Aerosol Generators - to kill Flies, Mosquitoes, Small Flying Moths and Gnats: Cover or remove exposed food and food handling surfaces. Close room and shut off all air conditioning or ventilating equipment. Apply at the rate of 0.5 oz. of undiluted Concentrate per 1,000 cubic feet of space. Direct output from aerosol generator upward towards upper corners of room and ceiling. Leave room closed for one hour. Ventilate room thoroughly before re entry.

Space Spray - Diluted for Ordinary Mechanical Fogging Equipment - to kill Flies, Small Flying Moths and Gnats: Cover or remove exposed food and food handling surfaces. Close room and shut off all air conditioning or ventilating equipment. Dilute Concentrate with oil at the rate of 1 part Concentrate plus 30 parts of oil and mix well. Apply at the rate of 50 fluid ounces dilute spray (0.4 gallons) per 25,000 cubic feet of space. Direct fog upward towards upper corners of room and ceiling area. Leave room closed for one hour. Ventilate room thoroughly before re entry.

Contact Spray - Diluted for use with sprayers that give large, wetting spray particles - to kill Cockroaches and accessible stages of Granary Insects - Rice Weevils, Contused Flour Beetle, Indian Meal Moth and Mediterranean Flour Moth Adults, Caddisles, Grain Mites and Sawtoothed Grain Beetles: Cover or remove exposed food and close room.
