ALUMACIDE is a very hard plastic antifouling paint designed for aluminum boats and outboard motors. It does not contain any metallic copper or mercury which are responsible for galvanic corrosion. In certain areas where heavy fouling conditions exist, it is suggested that the bottom be cleaned and repainted in midseason. This product is not effective against algal fouling organisms.

DIRECTIONS

ALUMACIDE may be applied over existing marine enamel, but best results are obtained by removing the old paint to bare metal. If the old paint contains copper or mercury, it must be removed to prevent corrosion. Wash the bare metal surface with PETTIT'S #120 BRUSHING THINNER to clean off grease, oil or other foreign materials. Wipe dry with a clean rag. Apply the following system:

- Brush or spray one light transparent coat of PETTIT'S METAL PRIMER. Let dry 30 to 60 minutes — do not sand.
- Brush or spray one hiding coat of PETTIT'S VINYL RED UNDERCOATER. Let dry 30 to 60 minutes; then sand lightly with fine sandpaper.
- Brush or spray two coats of ALUMACIDE. Allow one to two hours between coats and immersion.

If thinning is necessary, we recommend 5% to 10% addition of PETTIT'S #120 BRUSHING THINNER or 20% of PETTIT'S #121 SPRAYING THINNER for spray application.
