DIRECTIONS FOR USE

Vitavax-25 DB Fungicide is a ready to use seed treatment fungicide. It has been formulated to be applied directly to seed in the planter. The recommended rate (see below) should be thoroughly mixed with the seed in the planter to insure proper coverage.

CORN

Vitavax-25 DB Fungicide controls seed rots and provides systemic control of seedling diseases on corn. Vitavax-25 DB Fungicide should be applied directly to the seed in the planter at a rate of 4-6 ounces per 100 pounds of seed.

USE RESTRICTIONS

Do not use treated seed for food, feed or oil purposes. Do not graze or feed livestock on treated areas for six weeks after planting.

COMPATIBILITY

Vitavax-25 DB Fungicide can be applied to seed that has previously been treated with other seed protectant fungicides such as captan or thiram.
