HAZARDS TO HUMANS
WARNING**

DIRECTIONS

COTTON

VITAVAX® -30C concentrate controls *Rhizoctonia solani* on cotton. Mix one (1) gallon of VITAVAX® -30C with five (5) gallons of water, and apply mixture at the rate of twenty (20) fluid ounces per 100 pounds of seed.

PEANUTS

Use 3 fluid ounces of VITAVAX® -30C per 100 pounds of seed as a part of Gustafson's PRO-IZED™ Systems. Consult Gustafson's Botran-30C label for complete mixing and application instructions.

USE PRECAUTION

When using formulations that do not contain dye, to comply with 21 CFR Chapter 1, Section 2.25, all grain seed treated with an economic poison must be colored to distinguish and prevent subsequent inadvertent use as a food for man or feed for animals.
