

**PRECAUTIONARY

HAZARDS TO HUMANS**

WARNING

1. PROHIBITIONS

INFORMATION

**DIRECTIONS
COTTON**

VITAVAX®-30C Concentrate controls *Rhizoctonia solani* on cotton. For early season plantings in cold soils, use the highest recommended rate per 100 pounds of seed. Under severe planting conditions, use a supplemental EPA approved in-turrow granule to aid in disease control.

Use VITAVAX®-30C Concentrate at the rate of 3.3 fluid ounces to 6.6 fluid ounces per 100 pounds of cottonseed. Mix with enough water to apply mixture (slurry) at the rate of twenty (20) fluid ounces per 100 pounds of seed.

PEANUTS

Use 3 fluid ounces of VITAVAX®-30C per 100 pounds of seed as a part of Gustafson's PRO-IZED Systems. Consult Gustafson's Botran-30C label for complete mixing and application instructions.

USE PRECAUTION

When using formulations that do not contain dye, to comply with 21 CFR Chapter 1, Section 2.25, all grain seed treated with an economic poison must be colored to distinguish and prevent subsequent inadvertent use as a food for man or feed for animals.

USE RESTRICTIONS — Do not use treated seed for food, feed or oil purposes. Do not graze or feed livestock on hay grown from treated seed.

Do not hog down peanuts grown from treated seed.
