The labeling submitted with your subject letter in connection with registration under the Federal, Insecticide, Fungicide and Rodenticide Act (FIFRA) as amended is acceptable provided that you:

1. Revise the "Environmental Hazards" statement: "Do not contaminate....." to read: "Do not clean equipment or dispose of equipment washwaters in a manner that will contamiate water resources".
2. Under "Seed Labeling" correct the spelling of "manufacturer's"
3. That you will submit/cite all data required for registration/reregistration of this product under section 3(c)(5) when the Agency requires all registratants of similar products to submit such data.
4. Submit five (5) copies of the final printed labeling before releasing the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the labeling is enclosed for your records.

DIRECTIONS FOR USE

✓ It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Do not apply this product through any type of irrigation system.

✓ Wear goggles or face shield when handling. Wash thoroughly with soap and water after handling. Remove contaminated clothing and separately launder clothing before reuse.

✓ Mixers/loaders when mixing and loading this product must wear a long sleeved shirt and long pants or a coverall that covers all parts of the body except the head, hands and feet. Wear chemical resistant gloves, goggles or a face shield and a chemically resistant apron.

✓ A dust mask must be worn when mixing and loading this product.

✓ AFTER WORK: Take off all clothes and shoes. Shower using soap and water. Do not wear contaminated clothing. Wash protective clothing and equipment with soap and water after each use. Personal clothing worn during use must be laundered separately from household articles. Clothing and protective equipment heavily contaminated or drenched with captan must be destroyed according to state and local regulations.

SOYBEANS

✓ VITAVAX-CAPTAN HBM-25 is a ready-to-use seed treatment which combines the systemic action of carboxin with the surface action of captan to control various seed and seedling diseases of soybeans. In addition, the essential soybean micronutrient molybdenum is present.

VITAVAX-CAPTAN HBM-25, as a planter box application, should be applied at the rate of 2-4 ounces per bushel of seed.

✓ Use the higher rate under conditions of expected heavy disease pressure.

Do not use treated seed for food, feed or oil purposes. Do not graze or feed livestock on hay grown from treated seed.

CARE MUST BE EXERCISED IN THE HANDLING OF TREATED SEED.

✓ "This seed is treated with carboxin and Captan (VITAVAX-CAPTAN HBM-25 Fungicide) at the manufacturer's recommended rate. Do not use treated seed for food, feed or oil purposes."
