##### COTTON

(Seedling Disease Complex - Rhizoctonia, Pythium and Fusarium)

**SOIL IN-FURROW APPLICATION:** At planting time, use 8 to 12 lbs. per acre (per 13,000 linear feet based on 40 in. rows).

Apply the specified dosage to the soil around the seed and to the covering soil as it fills in the furrow. The soil around the seed and the covering soil should be thoroughly mixed with the product. The higher rates should be used when weather conditions are expected to be unfavorable for rapid germination, fields have a history of disease problems or minimum or low till programs are utilized.

Apply only at planting time.

Do not exceed 2 lbs. of PCNB active ingredient per acre in any one season applied as spray or granular formulations.

Do not allow the feeding or grazing of cotton foliage by livestock.

**ROTATION RESTRICTION:** Do not plant root crops in PCNB treated fields within 12 months of application unless PCNB is registered for use on those crops.

#### STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

**STORAGE** - Store in a dry location.

**PESTICIDE DISPOSAL** - Pesticide wastes are toxic. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal Law. Dear Mr. Taylor:

Uniroyal Chemical Company, Inc. is submitting a notification of an amended label for Terraclor Super X Granular which has been revised to comply with PR Notice 93-6, False and Misleading Statements Related to Efficacy and PR Notice 93-3, Labeling Statement Prohibiting Application to Water. Enclosed are five copies of the amended label.

The trade name Super X has been in use for many years and denotes the inclusion of two active ingredients in the formula. In an EPA letter, dated May 28, 1993, regarding PR Notice 93-6 Lawrence Culleen suggested that we provide on the label a brief explanation of trade name terms such as Super, to avoid misleading pesticide buyers. A copy of the letter is enclosed. As suggested, the subject label contains the clarification "Terraclor Super X contains two active ingredients, Terraclor® and Terrazole®".

In compliance with PR Notice 93-3, we have added the Environmental Hazards statement, "Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark". In a June 18, 1993 letter, Lawrence Culleen indicated that the phrase "For terrestrial uses" can be omitted from the above statement when all uses on the label are terrestrial. A copy of the letter is attached.
