GENERAL INFORMATION

VIGILANTE Insecticide Controlled-Released Bolus for Cattle controls the breeding of horn flies and face flies in the same manure of treated beef and dairy cattle for up to 5 months. The Bolus also aids in the control of house flies and stable flies.

APPLICATION INSTRUCTIONS

Administer Bolus using standard balling gun according to the operating instructions which accompany the instrument.

DO NOT exceed one bolus for 500 kilograms (1100 lbs.) of body weight. Each animal should be treated according to the following table.

FOR CATTLE WEIGHING WEIGHING	ADMINISTER THIS NUMBER OF BOLUSES
300 to 550 lbs.*	1/2
550 to 1100 lbs. or greater**	1

*DO NOT administer to cattle weighing less than 300 lbs.

**DO NOT administer more than one bolus to an animal weighing more than 1100 lbs.

Initiate treatment at the beginning of the target fly season or in accordance with local recommendations.
