The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable with the following provisions:

Although the use of a balling gun does reduce the amount of exposure of active ingredient to the
applicator, a potential for exposure still exists. Delete the "USER SAFETY RECOMMENDATION"
portion of the label and replace with the following:

"USER SAFETY RECOMMENDATIONS"

Users should:

- -Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet.
- -Remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing."
- 2. Due to the fact that balling guns need to be either washed or disposed of after product application, the potential for active ingredient to contaminate water exists. The following section should be included on the label:

"EVIRONMENTAL HAZARDS"

This pesticide is toxic to aquatic invertebrates. Do not contaminate water by cleaning of equipment or disposing of equipment wastewater or rinsate."

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

STORAGE AND DISPOSAL

DO NOT contaminate food or water by storage.

STORAGE: Store in a cool, dry place. Avoid exposure to direct sunlight for extended periods of time.

GENERAL INFORMATION

VIGILANTE FLYSTOP BOLUS provides a 5 month fly control by treating the manure of each animal. The Fly Growth Regulator we use breaks the fly life cycle by preventing the formation of the fly's exoskeleton when they molt (resulting in their death). This is a reduced risk pesticide and there is no withdrawal for meat or milk.

Treat your cattle with VIGILANTE Fly Stop in the Spring when you deworm and vaccinate. In this way you have treated the manure from the early Spring right into the Fall. For complete Fly Control also use Pour On's and Insecticide Tags to kill the adult flies. No resistance with the VIGILANTE FLYSTOP BOLUS, it stops all pyrethroid and organophosphate resistant flies from ever taking flight.

APPLICATION INSTRUCTIONS

Administer Bolus using standard balling gun according to the operating instructions which accompany the instrument.

DO NOT exceed one bolus for 500 kilograms (1100 lbs.) of body weight. Each animal should be treated according to the following table.
