Do not use FLORAMITE SC/LS on ornamentals grown and / or maintained in interiorscapes or for commercial production, such as in greenhouses, shadehouses and nurseries.

When used as directed and applied to the foliage, FLORAMITE SC/LS provides quick knockdown through contact activity, and long residual control. Due to its unique chemistry, mode of action and selective nature, FLORAMITE SC/LS is relatively inactive against beneficial / predacious mites and insects, and therefore is compatible with IPM and resistance management programs.

#### **MIXING INSTRUCTIONS**

Fill the spray tank with 1/2 the desired amount of water. Then add the required amount of FLORAMITE SC/LS with agitation running to fully disperse the product. Then fill the tank with the remaining amount of required water.

#### **Restrictions:**

Do not apply FLORAMITE SC/LS to the same crops more than once every 30 days.
