You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. A variety of mite species, especially spider mites, red mites and grass mites. This product is not effective against rust mites; broad mites and flat mites. FLORAMITE H&G is primarily active on the motile stages of mites, but also has activity against spider mite eggs.

#### WHERE TO USE:

- All ornamental plants, including bedding plants, flowering plants, foliage plants, ornamental plantings, perennials, trees and shrubs.
- All non-bearing fruit trees which will not bear fruit for a minimum of 12 months.

Do not apply to fruits or vegetables used for food.

#### HOW MUCH TO USE:

Mix  $\frac{1}{4}$  -  $\frac{1}{2}$  teaspoons per gallon of water and apply as a full coverage spray to the foliage.

This product can be applied with all types of hand sprayers. Read and carefully follow the instructions for the type of sprayer you use.

#### WHEN TO USE:

Apply as soon as mites appear. An application can be made every 30 days up to 6 applications per year.

FLORAMITE H&G is not systemic in action; therefore complete coverage of both upper and lower leaf surfaces is necessary for effective control.

#### IMPORTANT

Neither the manufacturer nor the seller has determined whether or not FLORAMITE H&G can be used safely on all ornamental plants. FLORAMITE H&G has been tested on a variety of ornamental plants with no phytotoxicity observed at label rates. The user should determine the safety of FLORAMITE H&G by testing this product on a small number of plants. The end user assumes all risks arising out of application in a manner inconsistent with its labeling.
