- 2. Submit the following conditional data before the due date of 12/31/2010:
 - a. Storage Stability (830.6317) and Corrosion Characteristics (830.6320) studies.
- 3. Make the following changes to the label:
 - a. Change the product registration number to "EPA Reg. No. 400-570"
 - b. If you wish you may delete the signal word CAUTION from page 1 and from the HAZARDS TO HUMANS AND DOMESTIC ANIMALS section
 - c. If you wish you may delete the First Aid statements
 - d. If you wish you may delete the following statements from the section HAZARDS TO HUMANS AND DOMESTIC ANIMALS: "Causes moderate eye irritation. Harmful if absorbed through skin or inhaled. Avoid contact with skin, eyes or clothing. Wear protective eyewear. Avoid breathing vapor." If you wish to continue to use these warning statements delete "Wear protective eyewear."
 - e. On page 2 in the **GENERAL** section add the following sentence to the last paragraph: "Do not tank mix with any pesticide that has a prohibition against tank mixing."
 - f. On page 3 in the Note below the table for **Tank Mix with a Metalaxyl Product:**
 - 1. Delete the sentence "The seed treatment products may be mixed together before application."
 - 2. Change the first sentence of the **Note** to read "MAXIMUM USAGE when applying multiple metalaxyl and/or mefenoxam containing products to the same crop..."
 - g. On page 4 in the STORAGE AND DISPOSAL box move the section EQUIPMENT CLEANING to the end of the SEED TREATMENT EQUIPMENT section on page 2.
- 4. Submit one copy of the revised final printed label for the record before the product is released for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.



PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION

ENVIRONMENTAL HAZARDS

Do not contaminate water when disposing of equipment washwater or rinsate. Ipconazole may persist in soil, and long-term use in the same field may result in an accumulation of active ingredient. Groundwater Advisory: Metalaxyl is known to leach through soil into groundwater under certain conditions as a result of agricultural use. Use of this chemical in areas where soils are permeable, particularly where the water table is shallow, may result in groundwater contamination.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Read all label directions carefully before use.

Do not apply this product in a way that will contact workers or other persons. Only protected handlers may be in the area during application. For any requirements specific to your State or Tribe, consult the agency responsible for pesticide regulation.

AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR Part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE) and restricted-entry interval. The requirements in this box only apply to uses of this product that are covered by the Worker Protection Standard.

Do not enter or allow worker entry into treated areas during the restricted entry interval (REI) of 24 hours.

Exception: Once the seeds are planted in soil, the Worker Protection Standard, under certain circumstances, allows workers to enter the treated area without restriction if there will be no worker contact with the soil subsurface or treated seed.

GENERAL

RANCONA™ Summit is a systemic and contact broad-spectrum fungicide for seed treatment that protects against a wide variety of diseases. RANCONA Summit is effective against Fusarium, Diaporthe (Phomopsis), Rhizoctonia, Sclerotinia and Pythium. It is also effective against seed rot fungi such as Aspergillus and Penicillium. Seed should be sound and well cured before treatment.

RANCONA Summit may be used in combination with a metalaxyl containing product (such as MetaStar™ ST) for enhanced *Phytophthora* protection. Do not use RANCONA Summit in combination with other seed treatment products unless their compatibility has been verified. Always read and follow carefully all label directions and precautions of each combination product. When using combinations of products, the most restrictive of label limitations and precautions must be followed.

SEED TREATMENT EQUIPMENT

RANCONA Summit may be applied with mechanical, slurry, or mist-type seed treating equipment, provided that the equipment can be calibrated to accurately and uniformly apply the product to seed. Uniform application to seed is necessary to ensure best disease protection and optimum performance. Seed should be sound and well cured before treatment. Refer to the label rates below.

In most cases, RANCONA Summit is ready to use and may be applied to seed as-is. However, to achieve more uniform product to seed coverage, dilution with water may be appropriate for some types of treaters and/or when treating under dry and/or hot conditions. Mix RANCONA Summit and water thoroughly into a slurry before treating seed. Recalibrate treating equipment to compensate for the addition of water. The amount of dilution water that is most suitable depends on the seed, the treater type and the temperature. Use a total slurry application volume of 4.0 fl. oz. (that is, as-is) to 15 fl. oz. per 100 lb. of seed. Contact your local Chemtura representative or supplier for specific recommendations.





Application rate (all crops): 4 fl.oz./100 pounds of seed

(This equals 0.04 oz. ipconazole plus 0.064 oz. metalaxyl per 100 pounds)

Tank Mix with a Metalaxyl Product

RANCONA Summit provides control of *Pythium* and protection against *Phytophthora*. However, if the target field has a history of high *Phytophthora* pressure, RANCONA Summit may be applied in combination with a product containing metalaxyl (such as MetaStar™ ST) at the rate registered for your crop for increased protection. For example, use the following rates when mixing RANCONA Summit with MetaStar ST. Use a higher rate of MetaStar ST when the field has a history of higher *Phytophthora* pressure:

Product	Rate
RANCONA Summit +	4.0 fl.oz/100 lb. of seed +
MetaStar ST	0.17-0.53 fl.oz/100 lb. of seed

NOTE: MAXIMUM USAGE when applying both Metalaxyl and Mefenoxam containing products to the same crop within the same season. DO NOT apply more than the maximum seasonal total for the active ingredient as stated on the label of the lowest seasonal total on that crop.

The seed treatment products may be mixed together before application. Agitate the slurry to maintain uniformity. Recalibrate your treating equipment to compensate for the addition of the metalaxyl product. Read and follow carefully all label directions and precautions of each combination product. When using combinations of products, the most restrictive of label limitations and precautions must be followed.

TREATED SEED LABELING

Seeds treated with this product that are then packaged or bagged for future use must contain the following labeling on the outside of the seed package or bag:

"This package or bag contains seed has been treated with ipconazole and metalaxyl. Do not use for food, feed or oil purposes. Store away from feeds and foodstuffs. Persons opening this bag or package or loading/pouring the treated seed must wear a long-sleeved shirt, long pants, shoes and socks."

USE RESTRICTIONS

Do not use treated seed for food, feed or oil purposes. Care must be exercised in the handling of treated seed. Do not use augers used for handling treated seed to move seed for feed, food or oil processing. Do not re-use bags from treated seed to handle food or feed products.

IN CALIFORNIA: ONLY for use in commercial seed-treatment establishments. NOT allowed for "on-farm" use.

ALWAYS SHAKE OR STIR PRODUCT WELL BEFORE USE

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. **PESTICIDE STORAGE:** Store in original container only. After partial use, replace lid and close tightly. Store in a secure place that is temperate, dry and out of direct sunlight. Avoid excess heat. Do not freeze.

PESTICIDE DISPOSAL

Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. Cover or incorporate spilled treated seeds.

EQUIPMENT CLEANING: Following applications, thoroughly rinse seed treatment equipment with water. Do not contaminate water by disposal of equipment washwater or rinsate.

CONTAINER DISPOSAL: Nonrefillable Container

Plastic containers: Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Then offer container for recycling, reconditioning, or puncture and dispose of in a sanitary landfill, by incineration, or if allowed by State and local authorities, by burning. If burned, stay out of smoke.

Refillable Container

Refill this container with pesticide only. Do not reuse this container for any other purpose. Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the refiller.

To clean the container before final disposal, empty the remaining contents from this container into application equipment or mix tank. Fill the container about 10% full with water. Agitate vigorously or recirculate water with the pump for 2 minutes. Pour or pump rinsate into application equipment or rinsate collection system. Repeat this procedure two more times.

Once cleaned, some agricultural plastic pesticide containers can be taken to a container collection site or picked up for recycling.
