

RANCONA<sup>®</sup> CTS Seed Protectant is a systemic and contact broad-spectrum fungicide for seed treatment that protects against a wide variety of diseases. RANCONA CTS is effective against smuts, bunts, *Fusarium, Diaporthe (Phomopsis), Rhizoctonia, Pythium* and seed-borne *Sclerotinia.* It is also effective against seed rot fungi such as *Aspergillus* and *Penicillium*. Seed should be sound and well cured before treatment.

RANCONA CTS Seed Protectant may be used in combination with a mefenoxam or metalaxyl containing product (such as BELMONT<sup>®</sup> 2.7 FS) for enhanced *Pythium* and *Phytophthora* protection. Agitate the slurry to maintain uniformity. Recalibrate treating equipment to compensate for the addition of the other seed treatment products.

Empty the rinsate into application\_equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. #### **Refillable container**
