

RANCONA[®] CTS Seed Protectant is a systemic and contact broad-spectrum fungicide for seed treatment that protects against a wide variety of diseases. RANCONA CTS is effective against smuts, bunts, *Fusarium, Diaporthe (Phomopsis), Rhizoctonia, Pythium* and seed-borne *Sclerotinia.* It is also effective against seed rot fungi such as *Aspergillus* and *Penicillium*. Seed should be sound and well cured before treatment.

RANCONA CTS Seed Protectant may be used in combination with a mefenoxam or metalaxyl containing product (such as BELMONT[®] 2.7 FS) for enhanced *Pythium* and *Phytophthora* protection. Agitate the slurry to maintain uniformity. Recalibrate treating equipment to compensate for the addition of the other seed treatment products.

Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 60 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application_equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. If used in application equipment, adjust the slurry volume application rate to account for any added rinsate water.

Refillable container
