Apply once a week or oftener if necessary. Dust up under leaves as well as top surface. Repeat ap-

timely applications.

As a Wet Spray: Add 10 tablespoonfuls of Imperial Rose and Floral Dust to 1 gallon of water in an acceptable garden sprayer. Shake or agitate spray solution. Spray foliage thoroughly, covering underside as well as top of leaves. Apply once a week or oftener if necessary. Repeat applications after heavy rain.
