#### **DIRECTIONS**

Place Rat and Mouse Killer in a protected spot where the rats and mice ordinarily feed and water, or where they travel or live.

Use shallow containers for the bait. Bait should be placed in locations not accessible to children, pets, and domestic animals or in tamper proof bait boxes.
