

HORN FLY CONTROL: Make first application when first horn flies are noticed in the spring. Repeat when necessary for control. Apply 1½ pints of mixture to the backs of the animals only, if using low pressure (20-60 pounds) spraying equipment. If high pressure (200-400 pounds) sprayers are used, cover entire animal, using about 1½ gallons of mixture per mature beef animal.

FOR BACKRUBBER USE: Dilute 1 cup with 4 quarts fuel oil. Apply the diluted material to saturate the backrubber mechanism. Recharge the backrubber every 2 weeks or as necessary for control. Locate backrubber to give cattle free access to it. Do not allow calves under 3 months of age, or dairy animals, or animals within 4 weeks of slaughter, to treat themselves.
