Apply by means of a coarse spray, paint brush or pressurized spray toward insects, into cracks and crevices (such as openings in expansion joints, between equipment and floors), along walls, baseboards and under storage platforms, around the base of machinery, containers of stored products and other areas where insects may hide or enter premises.
