
IN MUSHROOM PRODUCTION AND PROCESSING: To control adult Phorids, Sciards, and Cecidomyids in growing houses, apply at a rate of 1 ounce per 1,000 cubic feet of space. Fogger should be operated 8 to 10 feet away from beds and directed slightly upward over them. Circulating fans should be left in operation, but for best results, refrigeration should be turned off. In packing and canning plants, use at a rate of 1 ounce to 2,000 cubic feet of space.



IN AND AROUND FOOD PROCESSING PLANTS, DAIRIES, AND HOMES: To control ants, centipedes, clover mites, cockroaches, crickets, earwigs, silverfish, spiders, and pantry pests (cigarette, drug store, flour and sawtoothed grain beetles, Indian meal moth and rice weevil).

Apply by means of a coarse spray, paint brush or pressurized spray teward insects, into cracks and crevices (such as openings in expansion joints, between equipment and floors), along walls, baseboards and under storage platforms, around the base of machinery, containers of stored products and other areas where insects may hide or enter premises.
