

## DIRECTIONS FOR USE

Distribute Ronnel Granules with a mechanical spreader, scoop, or can. Avoid contact with bare hands.

**Control of Hog Lice:** Apply granules evenly over the bedding for swine at the rate of 1/2 pound per 100 square feet (an area 10 ft. by 10 ft.). No mixing with bedding is necessary. One treatment will control hog lice infestation when animals use the bedding regularly. Re-treat if infestation reoccurs.

**Control of Chicken Body Lice:** Scatter granules evenly over the litter at the rate of 1 pound per 100 sq. feet (an area 10 ft. by 10 ft.) Granules may be used in broiler, layer, and replacement pullet houses. Re-treat if infestation reoccurs.

**Control of Housefly Maggots (larvae):** Caged-Layer Poultry Houses: Apply granules at the rate of 1 pound per 100 sq. feet (an area 10 ft. by 10 ft.). Apply evenly over manure piles, under layer cages, and over the floor area where flies breed. Re-treat as needed.

### CAUTION

Harmful if swallowed. Avoid skin contact. Avoid contamination of food and feedstuff. Keep out of lakes, streams and ponds. Wash thoroughly with soap and water after handling. In case of eye contact, flush eyes with plenty of water. Get medical attention if irritation develops.

**Note to Physician and Veterinarian:** This material is a cholinesterase inhibitor. Treat symptomatically. Atropine is an antidote.

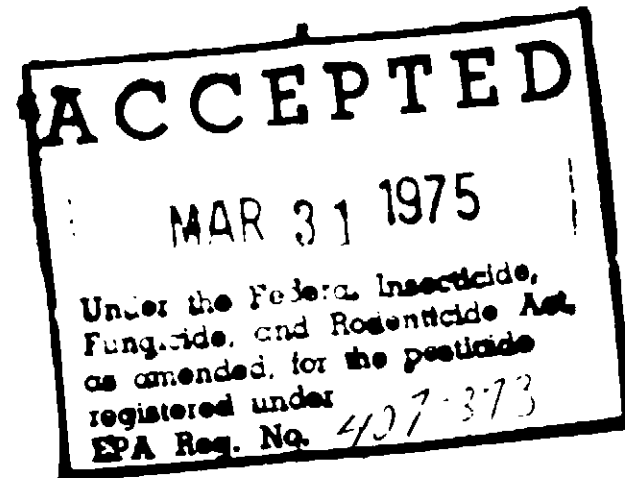
### ENVIRONMENTAL CAUTIONS

Do not reuse container. Dispose of by burning or burying in non-croplands away from water supplies. Stay out of smoke or fumes.

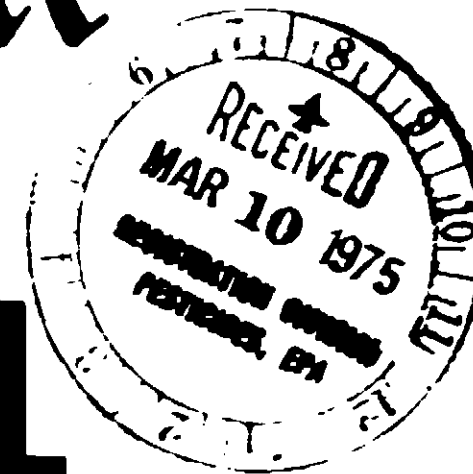
