#### STORAGE AND DISPOSAL

STORAGE: Store in original container, in a cool, dry, secure area away from fertilizer, food or feed. Keep container closed.

PRODUCT DISPOSAL: Securely wrap original container in several layers of newspaper and discard in trash.

CONTAINER DISPOSAL: Do not reuse empty container. Wrap container and put in trash.

Apply to dry foliage in the evening when air is calm. Begin application soon after plants are established or when insects or disease conditions threaten. Apply at 5 to 7 day intervals. Apply a light, even coating of dust to both upper and lower leaf, surfaces.

### IT IS IMPORTANT THAT FOLIAGE BE KEPT DUSTED, ESPECIALLY NEW GROWTH.

TOHATORS: For anthracnose, early and late blights, grey leaf spot (stemphylith); septoria leaf spot, and the insects tomato fruitworm, yellow striped armyworm, applies, spider mites, tomato russet mite, leafhoppers, apply at the rate of .1 lt. per 100; square feet (1.5 oz.). Do not exceed 40 lb. per acre. Do not use on tomatoss within 5, days of harvest.
