PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: Keep away from humans, domestic animals and pets. If swallowed, this material may reduce the clotting ability of the blood and cause bleeding.

NOTE TO PHYSICIAN. If ingested, administer Vitamin K₁ intramuscularly or orally, as inducated in bishydroxycoumarin overdoses. Repeat as necessary based on monitoring of prothrombin times.

ENVIRONMENTAL HAZARDS

Keep out of lakes, streams, or ponds. Do not contaminate water by cleaning of equipment or disposal of waste.

DIRECTIONS FOR USE

STORAGE: Store in original container, in a cool, dry area inaccessible to children and pets. Keep container closed.

PRODUCT DISPOSAL: Securely wrap original container in several layers of newspaper and discard in trash.

CONTAINER DISPOSAL: Do not reuse empty container. Wrap container and put in trash.

USE RESTRICTIONS: For control of Norway rats, roof rats, and house mice in and around homes, industrial and agricultural buildings and similar man-made structures and inside transport vehicles (ships, barges, railcars, aircraft).

SELECTION OF TREATMENT AREAS: Determine areas where rats/mice will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been observed. Protect bait from rain or snow. Remove as much of any other food source as possible.

APPLICATION DIRECTIONS:

Treated baits must be placed in tamper-proof bait boxes or in locations not accessible to children, pets, domestic animals, or wildlife. Do not place bait in areas where there is a possibility of contaminating food or surfaces that come in direct contact with food.

FOR RATS -- Place 4 to 16 oz. of bait per placement. Maintain ar uninterrupted supply of fresh bait for at least 10 days.

FOR MICE -- Place 1/4 to 1/2 oz. (1 to 2 level tablespoons) of bait at 8 to 12 foot intervals. Larger placements (up to 2 oz.) may be needed at points of very high mouse activity. Maintain an uninterrupted supply of fresh bait for at least 15 days.

Replace contaminated or spoiled bait immediately. Collect and dispose of all dead animals and unconsumed bait properly. To prevent reinfestation, eliminate food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is near, such as a dump or uncontrolled area such as an abandoned building, establish permanent bait stations and replenish bait as needed.
