TERMITE CONTROL IN HOUSES-When termites are known to exist in foundation structures such as supporting pillars in steps and porches as well as in house sidings, and upper structures the soil adjoining the wood or adjacent to termite runs should be treated. Since the Termite nest is in the soil the natural thing to eliminate them is to cut them off from the nest. Open a trench around the foundation or the adjacent wood structures 15 to 30 inches deep, but not below the top of the footing if this is more shallow. Deep foundations should have a 30 inch deep trench. Treat the bottom of the trench with ½ gallon per linear foot and apply 1/2 gallon to the fill dirt. Inspect treated areas frequently for reinfestations.
