Flies, Mosquitoes, Wasps and Flying Moths-Outdoors.

Also treat surfaces around light fixtures on porches, in garages, and other places where these insects alight or congregate.

Fleas, Chiggers, Ants and Brown Dog Ticks-Outdoors.

For treatment of localized infestations of these insects in outdoor areas where there is no vegetation. Spray infested areas thoroughly. For ants, thoroughly wet hills and runways. Repeat applications as infestations warrant, and as reinfestations occur.
