## FLYING INSECTS

### Directions

Cenol Mill Spray for control of flying insects; i.e., Flies, Gnats, Mosquitoes, and Flying Moths (Adult Mediterranean Flour Moth, Indian Meal Moth and Angoumois Grain Moth.).

Spray into entire room, after closing of all air currents. Spray should be directed upward at walls and ceilings so that as many insects as possible can be contacted with a direct vapor or mist. Permanent Spraying Systems, either automatic or semi-automatic, assist in this method. Electric, portable fogging devices such as the Challenger, Microsol, BVI Fogger, as well as air compressor units, can also be used.

Room should be kept closed at least ten minutes after spraying. Repeat as often as necessary to keep named insects under control. Periodic spraying assists in the control of new infestations of named insects. After thoroughly spraying as directed, sweep up all dead and dying insects and destroy them.

## CRAWLING INSECTS

### Directions

Cenol Mill Spray for control of crawling insects and stored product pests; i.e., Ants, Confused Flour Beetle, Red Flour Beetle, Rice Beetle, Cadelle, Saw-Toothed Grain Beetle, Dermestid Beetles such as Carpet Beetles, in their accessible stages. Thoroughly clean, preferably by vacuuming, all flour, grain, and food dust from horizontal surfaces, since these static accumulations encourage stored product pest breeding.

Spray with permanent units, portable electric sprayers, or air guns, into cracks, crevices, or any surface where the above named insects frequent. Apply into cracks of flooring and baseboards, also cracks inside and outside of flour, grain or food handling equipment or bins. Thoroughly mist outside of storage sacks before storing. Spray box ends and store rooms before filling with grain, feed, or food products. Repeat at regular intervals, or as often as necessary to control named insects.

### CAUTION

Foods should be removed or covered during treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using. When using the product as a space spray in these areas apply only when plant is not in operation.

This product is toxic to fish and birds. Keep out of any body of water. Do not apply where runoff is likely to occur. Do not apply when weather conditions favor drift from areas treated. Do not contaminate water by cleaning equipment or disposal of waste. Apply this product only as specified on this label.

Remove pets, birds, and cover fish aquariums before spraying.

DO NOT USE, POUR, SPILL OR STORE NEAR HEAT OR OPEN FLAME.

CONTAINER DISPOSAL: Do not reuse empty container. Destroy by perforating or crushing. Burn or discard in a safe place away from water supplies.
