**DIRECTIONS**

Close windows and doors; keep closed for 10 to 15 minutes after spraying. Hold container upright, direct spray away from operator, and press button. For flying insects spray at upward angle in air for time specified. For crawling insects spray as directed. Repeat as necessary. For best results spray at 70° F. or above. Remove birds and fish bowls from the room before spraying.

**FLYING INSECTS:** Mosquitoes, flies, gnats—Thoroughly mist room with the spray. Flying moths, wasps, hornets—Spray 20 to 25 seconds per 1000 cu. ft.

**CRAWLING INSECTS:** Roaches, ants, silverfish, spiders—Spray insects directly. Spray infested cracks and hiding places liberally.

**DIRECTIONS**

**MOTH WORMS, CARPET BEETLES—** Clean air and brush clothing, rugs, carpets and fabrics. Spray thoroughly from 3 ft. especially seams and folds. Clean and spray closets and drawers. Repeat every 30 days. **Bedbugs—**Spray bed-frame, springs, mattress tufts and seams, and in all cracks and hiding places in room.

**OUTDOORS:** In still air, spray near ground or shrubbery to help provide temporary relief from mosquitoes, gnats and like insects.

**CAUTION: DO NOT EXPOSE TO HEAT—**Radiators, stoves, heat from sun or confined heat in display windows, automobiles, etc., where temperatures might exceed 130° F. and may cause container to explode.

Avoid contamination of feed and foodstuffs.
