DIRECTIONS

DIRECT DUSTING OF DAIRY CATTLE to reduce Horn-Fly infestations use about four tablespoonsful (about an average handful) of Durham's Dairy Cattle Insecticide per animal. Sprinkle on poll, neck (top & sides) and back and upper sides: Rub in lightly by hand to carry powder beneath hair. Repeat treatments ~~every~~ every 3 weeks if necessary.

CAUTION: Do not apply to cows within 5 hours before milking. Do not use this powder as a spray. Do not allow powder to contaminate milk handling equipment, feedstuffs, feed troughs or water receptacles.

FOR DIRECT DUSTING OF RANGE CATTLE and HORSES Use as directed for Dairy Cattle, however for maximum protection on large range cattle or horses it would be advisable to use twice the amount of powder recommended for Dairy Cows — about two handfuls — in order to get the powder distributed uniformly along the animals neck and back as far back as possible.

CAUTION: Malathion, upon repeated, prolonged or careless use may cause cholinesterase inhibition and care should be used not to inhale the powder excessively. Wash hands thoroughly after using the dust. Atropine is antidotal. Avoid prolonged or repeated skin contact.
