

Subject: Rotenone Crystalline EPA Registration No. 432-46 Your amended application of January 19, 1995

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable provided that you:

- 1. Your current Confidential Statement of Formula (CSF) dated April 6, 1992, contains erroneous information. The meaning of the word "source" on a CSF means a material that is diluted or repacked, but not altered chemically, to make the <u>registered</u> product. If altered chemically, the material is considered a "manufacturing source." The registration number currently listed as your "source" is actually a "manufacturing source" and must be deleted. However, it would be acceptable to include this registration number in your CSF in your paragraph explaining how you manufacture Rotenone Crystalline.
- 2. The current name of the registrant, Agrevo Environmental Health, must appear on the label.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions. A stamped copy of the labeling is enclosed for your records.
