**DIRECTIONS FOR USE**

Remove protective cap. Aim spray opening away from person. Push button to spray.

**FOR HOUSE FLIES, MOSQUITOES AND GNATS:** Close all doors and windows. Point nozzle upward, direct the spray mist to all parts of the room, especially windows and other light sources which attract these insects. Fill the room with mist, then leave the treated area. Keep the room closed for at least 30 minutes. Ventilate the room when treatment is completed.

**WASPS:** Application should be made in late evening when insects are at rest. Spray liberally into hiding and breeding places, contacting as many insects as possible. Repeat as necessary.

**FOR CRAWLING INSECTS:** Roaches, earwigs, grain mites, sowbugs, spiders and centipedes. Spray thoroughly into hiding places such as cracks, crevices, moist areas, openings around pipes and sinks, under refrigerators, baseboards, and storage areas. Spray directly on insects where possible. Repeat as necessary.

**ANTS:** Spray trails, nests and points of entry. Spray on ants where possible. Repeat as necessary.
