BACK PAMEL

Kills fleas and ticks on dogs and cats and in other areas where fleas and ticks hide.

DIRECTIONS FOR USE: It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Shake can well before using. Aim spray opening away from person. Push button to spray.

Spray on dcgs and cats and pet bedding.

Spray where fleas and ticks hide.

To Kill Fleas & Ticks on Dogs and Cats: Apply directly to animals along back, under forelegs, and other areas except scrotum and anus. Part hair to contact skin and insure good coverage. Hold nozzle about one foot away while spraying. Apply until hair is thoroughly moist. Do not spray directly in eyes or mouth of animal. Repeat within 24 hours of first treatment, if necessary. Note: This aerosol may make a slight hissing sound and cause a temporary cool sensation. Hold pet securely while applying. Nervous animals may become frightened the first time this product is used but soon become accustomed to the treatment.

To Kill Fleas & Ticks in Pet Bedding and Pet Areas: To reduce reinfestation, thoroughly spray the animal's bedding and other resting places until the surface is slightly moist. Treat these areas at the rate of two seconds per linear foot at a distance of 12 to 18 inches. Also spray the entire inside surface of dog houses. Repeat as necessary.

To Treat Flea & Tick Infestation in Russ and Carpets: Spray rugs and carpets where fleas tend to hide. If used on light or delicate upholstery fabrics, test for potential staining in an inconspicuous place prior to use. Spray thoroughly into hiding places such as cracks and crevices, in walls and floors, along baseboards, windows and door frames. Repeat as necessary.

Roaches, Ants. Silverfish, Crickets, Sciders, Earwice, Cowbugs and Centificaes: Egray thoroughly into miding places such as chacks, crevices, moist areas, openings around pipes and sinks, under refrigerators, baseboards, storage areas and other areas where insects may be found. Spray directly on insects where possible. Repeat as necessary.

PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS
