The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below:

- Revise the Statement of Practical Treatment for IF SWALLOWED to read as follows: Call a doctor or get medical attention. Do not induce vomiting. Do not give anything by mouth to an unconscious person. Avoid alcohol.

This change to the labeling is necessitated by the percentage of aromatic petroleum solvent in the formulation.

The review of the storage stability and corrosion characteristics data submitted on April 21, 1996, is pending with the Product Chemistry Review Section. Results of that review will be forwarded to your company as soon as they are available.

A stamped copy of the label is enclosed for your records. Please submit three copies of revised final printed labeling prior to releasing product for shipment.
