SBP-1382 Insecticide Concentrate 12% Formula I  
EPA Registration Number 432-518  
Submission Dated January 19, 1996

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable provided that you make the labeling changes indicated below before you release the product for shipment bearing the amended labeling:

1. Move the paragraph beginning with "This product is intended for formulation use only" so that it is the second paragraph of the Directions for Use.
2. Move the paragraph beginning with "This product may be formulated into end-use products . . ." so that it is the third paragraph of the Directions for Use.
3. Revise the Statement of Practical Treatment to read:
  - IF SWALLOWED: Call a doctor or get medical attention. Do not induce vomiting. Do not give anything by mouth to an unconscious person. Avoid alcohol.
  - IF ON SKIN: Wash with plenty of soap and water. Get medical attention.
4. Revise the Precautionary Statements to read:
 

"Harmful if swallowed or absorbed through the skin. Avoid contact with skin, eyes or clothing. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse."

Submit five copies of your final printed labeling prior to releasing product for shipment.
