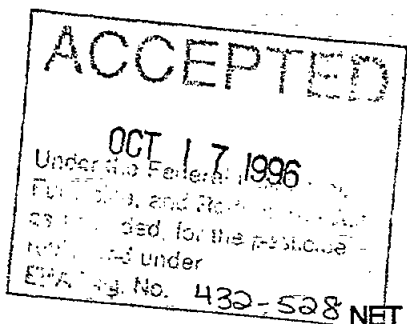
### STATEMENT OF PRACTICAL TREATMENT
