The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable provided that you make the labeling changes indicated below before you release the product for shipment bearing the amended labeling:

1. Move the paragraph beginning with "This product is intended for formulation use only" so that it is the second paragraph of the Directions for Use.
2. Move the paragraph beginning with "This product may be formulated into end-use products . . ." so that it is the third paragraph of the Directions for Use.
3. Add the "skull and crossbones" symbol to the front panel of the label in immediate proximity to the signal word "DANGER".

Submit five copies of your final printed labeling prior to releasing product for shipment.
