DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling. Shake well before each use. Remove protective cap. Aim spray opening away from person. Push button to spray.

DOUBLE ACTION INSECT KILLER - This is a dual purpose formulation that can be used as a contact spray against wasps and crawling insects and as a residual insecticide providing up to 3 to 4 weeks control of roaches.

Do not use on edible crops. Do not use in edible products areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed.

FOR INDOOR USE: Can be used in home kitchens, and in non-food areas of food handling establishments, commercial, industrial, office, residential, public, institutional and storage buildings, homes, hotels, ship cabins and hospitals. In hospitals, patients should be removed prior to treatment. Also for use in buses, automobiles, and non-food areas of trucks, boxcars and ship cargo holds. Do not use on electrical equipment or on surfaces that can be harmed or stained by water. Also for use in dog kennels and horse stables. In horse stables, not for application if horses will be used for food.

TO KILL ROACHES, EARWIGS, GRAIN MITES, SOWBUGS, SCORPIONS, SPIDERS AND CENTIPEDES:

Contact Spray: Spray thoroughly into hiding places such as cracks, crevices, moist areas, openings around pipes and sinks, under refrigerators, baseboards, and storage areas. Spray directly on insects where possible. Repeat as necessary.

Residual Spray: Spray baseboards, cracks, crevices, around door and window frames, and other hiding places such as closets, in back of and under appliances, sinks cupboards in the kitchen and bathroom. In basements, spray hiding places in cracks and crevices, lower walls, dark places. Spray at the rate of 3 to 4 seconds per linear foot at a distance of 12 to 14 inches from the surface. Repeat as necessary.

TO KILL SPIDERS AND SCORPIONS: Direct short burst of spray on spiders and scorpions and repeat as necessary.

TO KILL WASPS: Applications should be made in the late evening when insects are at rest. Spray liberally into hiding and breeding places, contacting as many insects as possible. Repeat as necessary.

TO KILL ANTS: Apply to ant trails and around door sills, window frames and other places where ants may enter.
