SBP-1382 24.3% Emulsifiable Insecticide

Submission Dated January 19, 1996

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable provided that you make the labeling changes indicated below before you release the product for shipment bearing the amended labeling:

1. Add the following statement as a footnote to the Inert Ingredients declaration:

"Contains aromatic petroleum hydrocarbons"

2. Revise the Statement of Practical Treatment for "IF SWALLOWED" to read:

IF SWALLOWED: Call a physician or Poison Control Center. Do not induce vomiting. This product contains aromatic petroleum hydrocarbons. Aspiration may be a hazard.

3. Revise the Statement of Practical Treatment for "IF ON SKIN" to read:

IF ON SKIN: Wash with plenty of soap and water. Get medical attention if irritation persists.

4. Revise the Precautionary Statements to read:

"Harmful if swallowed or absorbed through the skin. Avoid contact with skin, eyes or clothing. Avoid breathing mist. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse."

- 5. Move the paragraph beginning with "SBP-1382 24.3% Emulsifiable Insecticide may be used . . ." so that it appears as the second paragraph of the Directions for Use.

Submit five copies of your final printed labeling prior to releasing product for shipment.

A stamped copy of the label is enclosed for your records.
