


DIRECTIONS FOR USE

VEGETABLES To control Mexican Bean Beetle, Asparagus Beetle, Spotted and Striped Cucumber Beetles, Flea Beetles, Imported Cabbage Worm and Cabbage Looper on

Asparagus	Cucumbers
Beans	Eggplant
Beets	Spinach
Brussels Sprouts	Tomatoes
Broccoli	Turnips
Cabbage	Lettuce
Collards	Peas

Use 4 to 6 pounds per 100 gallons of water and apply 100 to 150 gals. per acre. Repeat as necessary for effective control. To control Mexican Bean Beetle direct material to under side of leaves. Do not apply more than 10 pounds of this product per acre. Do not apply within 1 day of harvest.
