ANTS: To kill ants, spray trails, nests and points of entry within buildings and homes. Spray directly on ants where possible. Repeat as necessary.

FLEAS, BROWN DOG AND LONE STAR TICKS: Thoroughly apply as a spot treatment to infested areas such as pet's beds and resting quarters; nearby cracks and crevices; along and behind baseboards, window and door frames and localized areas of floor and floor covering where these pests may be present. Old bedding of pets should be removed and replaced with clean fresh bedding after treatment of pet areas. Do not treat pets with this product. Treat pets with a product registered for animal application such as SBP-1382/Bioallethrin Aqueous Pressurized Spray, EPA Reg. No. 432-482, to control the source of flea and tick infestation.

CARPET BEETLES: Thoroughly apply as a spot treatment along baseboards and edges of carpeting, under carpeting, rugs and furniture, in closets and on shelving, and wherever else these insects are seen or suspected.

ATTENTION (PESTS INDOORS): Do not apply this water-based product in conduits, motor housings, junction and switch boxes or other electrical equipment because of possible shock hazard. If there is need to treat such areas use only oil-base sprays. Prior to application, de-energize electrical equipment. After application allow time for oil to evaporate before starting motors or placing switches in the "ON" position.

RESIDUAL SPRAY: Aids in the control of COCKROACHES, CRICKETS, SILVERFISH, CENTIPEDES, MILLIPEDES, EARWIGS, SOWBUGS. Kills up to 4 weeks. Apply on baseboards, cracks and crevices, around door and window frames, and other hiding places such as closets, in back of and under appliances, sinks and cupboards in kitchens and bathrooms. In basements, apply in hiding places in cracks and crevices, lower walls and dark places. Apply as a coarse wet spray in a 6 inch band until area is thoroughly wet but not to the point of run-off. Treat on a monthly basis or as necessary.

PESTS OUT-OF-DOORS

GENERAL INFORMATION: Use SBP-1382/Chlorpyrifos Transparent Emulsion Dilutable Concentrate 1.6 - 16 according to the SPRAY DILUTION CHART for control of certain pests on the outside surfaces of buildings. Consult the following directions for dosage and application details to control the pests listed.

PESTS ON OUTSIDE SURFACES OF BUILDINGS: Use SBP-1382/Chlorpyrifos Transparent Emulsion Dilutable Concentrate 1.6 - 16 to control ants, clover mites, crickets, earwigs, millipedes, and sowbugs by application as a residual spray or with a paint brush to outside surfaces of buildings, including porches, screens, window frames, eaves, patios, garages, refuse dumps and other areas where these pests congregate or have been seen. Do not treat or allow the spray to contact plants (lawns, flowering plants, shrubs, trees, evergreens, etc.) because of possible injury. Repeat treatment as needed to maintain effectiveness.

NOTE: To help prevent infestation of buildings by ants, crickets, earwigs and sowbugs (pillbugs), treat a band of soil 6 to 10 feet wide around and adjacent to the buildings, also the building foundation to a height of 2 to 3 feet, where pests are active and may find entrance. Use 25 ounces of SBP-1382/Chlorpyrifos Transparent Emulsion Dilutable Concentrate 1.6 - 16 per 100 gallons of water and apply as a coarse spray at the rate of about 10 gallons per 1000 sq. ft. to thoroughly and uniformly wet the band.
