This product is toxic to fish. Keep out of lakes, streams, ponds, tidal marshes or estuaries. Do not contaminate water by cleaning of equipment or disposal of wastes.

**PHYSICAL AND CHEMICAL HAZARDS**

Flammable. Keep away from heat and open flame. Flash point minimum 60°F.

**STORAGE AND DISPOSAL**

Do not contaminate water, food, or feed by storage or disposal.

**STORAGE:** Do not store at temperatures below 40°F. If exposed to temperatures below 40°F, warm to above 40°F and thoroughly mix before using.
