### PRECAUTIONARY STATEMENTS

#### HAZARDS TO HUMANS

##### DANGER

#### ENVIRONMENTAL HAZARDS

This product is toxic to fish, birds and other wildlife. Do not apply directly to water. Do not contaminate water by cleaning of equipment or disposal of wastes.

#### PHYSICAL AND CHEMICAL HAZARDS

Flammable. Keep away from heat or open flame. Flash point minimum of 60°F (15.5°C).

### STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

**STORAGE:** This material may stratify upon standing, even at room temperature. Thoroughly mix before each use. Do not expose to temperatures below 40°F (4.5°C). If exposed to temperatures below 40°F (4.45°C), allow to stand until product reaches room temperature and thoroughly mix before using. **DO NOT USE OPEN FLAME.**
