The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is not acceptable for the reasons listed below.

1. Delete the following use patterns from the product labels as these are not acceptable: Greenhouse Vegetable for minor use application, agricultural cropland, foraging areas and grazing land (agricultural sites).
2. Regarding product 432-577, include an appropriate STATEMENT OF PRACTICAL TREATMENT. Delete the phrase FIRST AID from the product label.
3. Regarding product 432-574:
 - a. Delete the phrase "FIRST AID" and replace this with the heading STATEMENT OF PRACTICAL TREATMENT.
 - b. The statement HAZARDS TO HUMANS should be written HAZARDS TO HUMANS AND DOMESTIC ANIMALS.

This will acknowledge that the compound aromatic petroleum solvent contained in the product formulations referenced above has been converted to inert status and is no longer listed as an active ingredient in the product formulation.

The cited products have been removed from the list of products to be cancelled, which is contained in the EPA FR Notice titled "Notice of Intent to Remove Certain Active Ingredients from Reregistration Lists B and C and to Cancel Pesticides Containing those Ingredients" [OPP-34012: FRL 3880-7], dated October 4, 1991.
