**PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS & DOMESTIC ANIMALS**

Harmful if swallowed. Avoid contact with eyes, skin and clothing. Wash hands after using. Do not contaminate food or feedstuffs with this spray. Do not allow children or pets to contact treated surfaces until spray has dried. Remove pets and cover fish bowls (tanks) before spraying. Do not use this product in edible product areas of food processing plants, restaurants or other area where food is commercially processed or prepared. Do not use in serving areas while food is exposed.

STATEMENT OF PRACTICAL TREATMENT
In case of contact, immediately flush eyes and skin with plenty of water. If irritation develops or persists, get medical attention.

NOTE TO PHYSICIAN: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine only by injection is an antidote.

INSTRUCTIONS FOR CONTACT AND RESIDUAL SPRAYS (Shake Well Before Using): FOR USE IN NON-FOOD AREAS INDOORS AND OUTSIDE PREMISES OF HOTELS, MOTELS, HOMES, PRESCHOOLS, APARTMENT BUILDINGS, COMMERCIAL, OFFICE, INSTITUTIONAL AND STORAGE BUILDINGS, RECREATIONAL BUILDINGS, BOATS, SHIP CABINS, AND HOSPITALS. INDOORS - TO CONTROL HOUSEHOLD PESTS:

CONTACT SPRAY: KILLS AND REDUCES INFESTATIONS: COCKROACHES, CRICKETS, SILVERFISH, CLOVER MITES, CENTIPEDES, MILLIPEDES, FIREBRATS, EARWIGS, SOWBUGS, ANTS, SPIDERS, FLEAS: Spray thoroughly into hiding places such as cracks, crevices, moist areas, openings around pipes and sinks, under refrigerators, baseboards, and storage areas. Spray directly on insects where possible. Repeat as necessary.

ANTS: To kill ants, spray trails, nests and points of entry within buildings and homes. Spray directly on ants where possible. Repeat as necessary.

FLEAS, BROWN DOG AND LONE STAR TICKS: Thoroughly apply as a spot treatment to infested areas such as pet's beds and resting quarters; nearby cracks and crevices; along and behind baseboards, window and door frames and localized areas of floor and floor covering where these pests may be present. Old bedding of pets should be removed and replaced with clean fresh bedding after treatment of pet areas. **DO NOT TREAT PETS WITH THIS PRODUCT.** Treat pets with a product registered for animal application such as SBP-1382* /Bioallethrin Aqueous pressurized Spray, EPA Reg. No. 432-482, to control the source of flea and tick infestation.

DIRECTIONS FOR USE (Continued)

CARPET BEETLES: Thoroughly apply as a spot treatment along baseboards and edges of carpeting, under carpeting, rugs and furniture, in closets and on shelving, and wherever else these insects are seen or suspected.

RESIDUAL SPRAY: AIDS IN THE CONTROL OF COCKROACHES, CRICKETS, SILVERFISH, CENTIPEDES, MILLIPEDES, EARWIGS, SOWBUGS. Kills up to 4 weeks. Apply on baseboards, crack and crevices, around door and window frames, and other hiding places such as closets, in back of and under appliances, sinks and cupboards in kitchens and bathrooms. In basements, apply in hiding places in cracks and crevices, lower walls and dark places.

ATTENTION (PESTS INDOORS): Do not apply this water-based product in conduits, motor housings, junction and switch boxes or other electrical equipment because of possible shock hazard. If there is need to treat such areas use only oil-base sprays. Prior to application, de-energize electrical equipment. After application allow time for oil to evaporate before starting motors or placing switches in the "ON" position.

PESTS OUT-OF-DOORS

PESTS ON OUTSIDE SURFACES OF BUILDINGS: Use SBP-1382/Chlorpyrifos Jet Stream APS 0.05 + 0.50 to control ants, clover mites, crickets, earwigs, millipedes, and sowbugs by application as a residual spray to outside surfaces of buildings, including porches, screens, window frames, eaves, patios, garages, refuse dumps and other areas where these pests congregate or have been seen. Do not treat or allow spray to contact plants (lawns, flowering plants, shrubs, trees, evergreens, etc.) because of possible injury. Repeat treatment as needed to maintain effectiveness.
