CARPET BEETLES: Thoroughly apply as a spot treatment along baseboards and edges of carpeting, under carpeting, rugs and furniture, in closets and on shelving, and wherever else these insects are seen or suspected.

RESIDUAL SPRAY: AIDS IN THE CONTROL OF COCKROACHES, CRICKETS, SILVERFISH, CENTIPEDES, MILLIPEDES, EARWIGS, SOWBUGS. Kills up to 4 weeks. Apply on baseboards, crack and crevices, around door and window frames, and other hiding places such as closets, in back of and under appliances, sinks and cupboards in kitchens and bathrooms. In basements, apply in hiding places in cracks and crevices, lower walls and dark places.

Do not treat or allow spray to contact plants (lawns, flowering plants, shrubs, trees, evergreens, etc.) because of possible injury. Repeat treatment as needed to maintain effectiveness.
