The revised confidential statement of formula referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable. The confidential statement of formula for the basic formulation (dated October 18, 1996) has been added to the product file and supersedes all previously-submitted confidential statements of formula for the basic formulation.

The revised labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below:

1. Until the Agency completes its review of the acute toxicity studies referenced in your October 18, 1996, letter, the product label should continue to bear the Precautionary Statements and Statements of Practical Treatment on the last accepted label for this product, May 17, 1991.
2. Revise the Precautionary Statement to read as follows:  
  
Harmful if swallowed or absorbed through skin. Avoid contact with eyes, skin, or clothing. Wash thoroughly with soap and water after handling.

3. Revise the Statements of Practical Treatment to read as follows:

IF IN EYES: Flush eyes with plenty of water. Get medical attention if irritation persists.

IF ON SKIN: Wash with plenty of water. Get medical attention if irritation persists.

Submit three copies of revised final printed labeling prior to releasing product for shipment.

### STORAGE & DISPOSAL
