The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable provided that you make the labeling changes indicated below before you release the product for shipment bearing the amended labeling:

1. Add the following statement as a footnote to the Inert Ingredients declaration:

"Contains petroleum distillates, xylene, or xylene range aromatic solvent"

2. Add a Statement of Practical Treatment for "IF SWALLOWED" that reads:

IF SWALLOWED: Call a physician or Poison Control Center. Do not induce vomiting. This product contains aromatic petroleum solvent. Aspiration may be a hazard. Avoid alcohol.

3. Revise the heading "INSTRUCTIONS FOR REPACKAGING" to read "Directions for Use"

Submit five copies of your final printed labeling prior to releasing product for shipment.

Additional data may be required to support registration of any repackaged product if the labeling, text or graphics are altered from example given and if the hazard or efficacy are affected by such alterations.

STORAGE & DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Storage: Do not store at temperatures below 40°F (4.5°C). If this material has been exposed to temperatures below 40°F (4.5°C), there may be precipitation. Check for crystallization. If evident, warm to 80°F (26.5°C) and thoroughly mix before using. **DO NOT USE OPEN FLAME.**
