

Hazards To Humans & Domestic Animals

CAUTION

Harmful if swallowed. Avoid contact with eyes, skin or clothing. Wash hands after using. In food handling areas, application is limited to crack and crevice and/or spot treatment. Do not apply directly to food or feedstuffs. In commercial food handling facilities, cover or remove any food or food processing equipment during application. Spray directly on insects where possible. Repeat as necessary.

ANTS (Including FIRE ANTS): To kill *Ants* within buildings and homes, spray trails, nests and points of entry. Spray directly on ants where possible. Repeat as necessary.

FLEAS, BROWN DOG AND LONE STAR TICKS: Thoroughly apply as a spot treatment to infested areas such as pets' beds and resting quarters; nearby cracks and crevices; along and behind baseboards, window and door frames and localized areas of floor and floor coverings where these pests may be present. Old bedding of pets should be removed and replaced with clean fresh bedding after treatment. **DO NOT TREAT PETS WITH THIS PRODUCT.** Treat pets with a product registered for animal application such as SBP-1 382/Bioallethrin Aqueous Pressurized Spray, EPA Reg. CARPET BEETLES AND CLOTHES MOTHS: Do not spray clothing with this product. Do not spray areas that will come into contact with clothing. Spray edges of carpeting and under carpeting, rugs, and closets. Make localized application to the floor and baseboards. Spray directly into cracks, crevices, closets, and infested areas of shelving and/or wherever these insects are seen or suspected. Repeat as necessary.

RESIDUAL SPRAY: Aids in the control of *Cockroaches (waterbugs), Crickets, Boxelder Bugs, Scorpions, Spider Beetles, Silverfish, Centipedes, Millipedes, Earwigs, Sowbugs (pillbugs):* Kills up to 4 weeks. Apply on baseboards, cracks and crevices, around door and window frames, and other hiding places such as closets, in back of and under appliances, sinks and cupboards in kitchens and bathrooms. In basements, apply in hiding places, in cracks and crevices, lower walls and dark places. Spray surfaces until wet, but not to the point of run-off.

PESTS OUT-OF-DOORS

PESTS ON OUTSIDE SURFACES OF BUILDINGS: Use this product to control *Ants, Clover Mites, Crickets, Earwigs, Millipedes, and Sowbugs* on the outside surfaces of buildings. Apply as a residual spray to outside surfaces of buildings, including porches, screens, window frames, eaves, patios, garages, refuse dumps and other areas where these pests congregate or have been seen. Repeat treatment as needed to maintain effectiveness.

HOUSE FLIES, MOSQUITOES, GNATS, FLYING MOTHS, OUT-DOORS: For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors,

window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures on porches, in garages, and other places where these insects alight or congregate. Repeat as necessary.

ANTS, LONE STAR TICKS, CRICKETS, FLEAS AND EARWIGS OUTDOORS: For treatment of localized infestations of these insects in outdoor areas where there are weeds or bushy non-crop areas, spray infested areas thoroughly. For *Ants*, thoroughly wet hills and runways. Repeat application as infestations warrant and as reinfestation occurs.

FIRE ANTS: Kills and reduces annoyance from these insects. To reduce annoyance from these ants and keep them from entering homes, spray patios, barbecue areas, driveways, entryways, door sills, window sills, other entrance areas, foundations of buildings, ant trails, around pools and other areas where the ants are noticed. Spray until the area is wet contacting as many insects as possible. This treatment will not kill the colonies but will reduce the immediate population. Repeat as necessary. Avoid contacting plants, shrubbery and large areas of lawns.
